2. The head cook agrees to be available at the cooking site for a scheduled Fire Inspection, if required.
3. If you plan to have an RV present, you are required to let us know on this form, or be prepared to have it some distance from your cook site.
4. We reserve the right to reconfigure sites to comply with local laws and/or codes.
5. Public sampling of any food by individual teams is strictly prohibited
